1. These Regulations may be cited as the

**QUARANTINE (PREVENTION OF THE SPREAD OF INFECTIOUS DISEASE) (COVID 19) (AMENDMENT) REGULATIONS, 2020,**

and shall be read and construed as one with the Quarantine (Prevention of the Spread of Infectious Disease) (COVID 19) Regulations, which are hereinafter referred to as the principal regulations.

2. Regulation 12 of the principal regulations is amended by repealing paragraph (a) and substituting the following–

Amendment of regulation 12.

“(a) restaurants, saloons, diners and other similar establishments holding a restaurant licence may operate for dining in services,

provided that guests of the same party, which party is limited to ten members, may be seated together,

provided further that owners or operators of restaurants, saloons, diners and other similar establishments shall observe a minimum distance of six feet between tables,

and provided further that dining shall be by reservation only;”.

Repeal of regulation 16.

3. Regulation 16 of the principal regulations is repealed.

Amendment of regulation 17.

4. Regulation 17 of the principal regulations is amended—

(a) in sub-regulation (1), by repealing paragraph (b) and substituting the following—

“(b) make arrangements with the hotel or tourist accommodation at which he is staying to be transported to that hotel or tourist accommodation by any means of transportation provided by that hotel or tourist accommodation or by any other means of transportation authorized by the Belize Tourism Board.”;

(b) repealing sub-regulation (4).

Amendment of regulation 20.

5. Regulation 20 of the principal regulations is amended by repealing sub-regulation (1).

Commencement.

6. These regulations shall come into force on the 19th day of October, 2020.
